Supervisor Lennox called the Regular Meeting to order at 7:00. Those present were Councilors Michele Robillard, Dianne Hurley, Mark Rice, Jeff Shippee and Highway Superintendent Duane Sykes. In attendance from the public Joel LaPierre, SLC Legislator, Rachael Hunter, Gouverneur Tribune Press, & Frank Wagner.

St. Lawrence County Legislator Joel LaPierre, Legislative District 4, handed out information by the county on towns within district 4. Showing rates project based on average change for last 4 years. Of the six towns the Town of Edwards has shown the biggest decrease in taxes for the 4 year period. He talked about the changes the Legislators have brought about to get the county running more efficient in the past 4 years. He left the meeting at 7:08.
