HIGHWAY MATTERS:

The Town of Edwards received a letter from the St. Lawrence County Highway Department stating the request to have the speed limit on County Route 23 reduce has been denied. The County will however change the yield sign at the intersection of County Route 23 and State Highway 58 to a stop sign.
